### INVESTMENT OBJECTIVE

The Cadiz BCI Bond Fund aims to generate returns above the FTSE JSE All Bond index ("ALBI") over time, utilizing active bond management combined with strategies which aim to reduce risk.

### INVESTMENT POLICY

In order to achieve its objective, the investments normally to be included in the portfolio will comprise a combination of assets in liquid form and a combination of bonds and interest-bearing securities, including loan stock, debentures, debenture bonds, money markets instruments, notes corporate debt and non-equity securities. The portfolio may also invest in participatory interests or any other form of participation in portfolios of collective investment schemes or other similar collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include forward currency swaps, interest rate and exchange rate swap transactions.

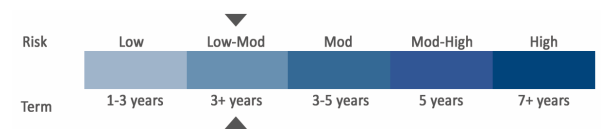
